#### 1. PURPOSE


The purpose is to submit a report on the proceedings of the Request for Quotation: opening report for the Supply and Delivery of NHIES Teaspoon, tablespoons and Height Scale, REF: G/RFO/NSA-05/2024. The Bid was advertised via the NSA website. The closing date was Friday, 18 October 2024. The issuing date was Thursday, 03 October 2024.

#### 2. BACKGROUND

The opening session was guided by section 51(4) of the Act, which states that: "*At a bid opening session, the name of the bidder, the total amount of each bid, any discount or alternative offer, and the presence or absence of any security, if required is read out and recorded, and a copy of the records is made available to any bidder on request.*" The PMU, therefore, focused on those aspects only. The bid evaluation process is expected to commence within five (5) days.
